NOTICE TO EMPLOYEES IN CASE OF WORK RELATED INJURIES

1. If you suffer a work related injury, your employer or its insurance company must pay for reasonable surgical and medical services and supplies, orthopedic appliances and prosthesis, including training in proper use.
2. In order to insure that your medical treatment will be paid for by your employer or the insurance company you must select from one of the following health care providers:

Note: Initial treatment for work-related injuries must be with the providers in bold print listed below, unless you are directed to the emergency room. All follow-up care or referrals to specialty physicians provided by:

YOU MUST CONTINUE TO VISIT ONE OF THE PHYSICIANS LISTED ABOVE, IF YOU NEED TREATMENT, FOR NINETY (90) DAYS FROM THE DATE OF YOUR FIRST VISIT.

3. If one of the persons above refers you to another licensed specialist, your employer or their insurer will pay for the services.
4. After the 90 day period, if you still need treatment and your employer has provided a list as set forth above, you may choose to go to another health care provided for treatment. You should notify your employer of this action within five days of your visit to said provider.
5. If a physician on the list prescribes invasive surgery, you may obtain a second opinion from any physician of your choice. If the second opinion is different than the listed physician's opinion, you may determine which course of treatment to follow; however, the second opinion must contain a detailed treatment plan. If you choose the second opinion, the procedures in that opinion must be performed by one of the physicians on the list for the first 90 days. Therefore, in this situation, the employee may be required to treat with an employer-designated provider for up to 180 days.
6. If you are faced with a medical emergency, you may secure assistance from a hospital, physician, or health care provider of your choice for your work related injury.
